

Background:

After the resignation of Dr. Daniel Larios as President of Fresno City College, the District advertised nationally to fill the position. A total of 49 completed applications were received. The screening committee consisting of administrators, faculty representatives, classified representatives and community representatives invited 10 people for semi-final interviews. Four of those individuals were invited for a final interview. Following site visitations and extensive background reference checking, the administration is pleased to recommend Dr. Ned Doffoney for the position. Dr. Ned Doffoney is currently the Founding President/Chancellor of South Louisiana Community College. He is responsible for the budget, recruitment of all staff, policy implementation, and public relations. For four years Dr. Doffoney was the President of Saddleback College at South Orange Community College District in Southern California, prior to that he was the Vice President of Academic Affairs at Los Angeles City College for four years. He has also served as Dean of Academic Affairs at L.A. Southwest College, Dean of Admissions, and Assistant Dean of Admissions and Financial Aid at LA. Trade-Technical College. Dr. Doffoney previously taught at California State University, Dominguez Hills. Dr. Doffoney received his Bachelor of Arts Degree in Economics as well as his Master's Degree in Vocational Rehabilitation Counseling from the University of Southwestern Louisiana in Lafayette, Louisiana. Dr. Doffoney received his Doctorate in Institutional Management from Pepperdine University in Los Angeles, California.

Fiscal Impact:

Replacing President position at no additional cost to the District.

Recommendation:

It is recommended that the Board appoint Dr. Ned Doffoney to the position of President, Fresno City College with an effective date of July 1, 2002, and a salary of \$139,000.
