Barbara Hioco provided a presentation on the educational master plan that the campuses will be developing to meet planning needs and accreditation requirements. She also explained the difference between the existing strategic plan and an educational master plan and why both are needed.

Michael Quinn, Cynthia Azari, Barbara Hioco, and Terry Kershaw provided presentations on current program changes and future career and technical education programs for Fresno City College, Reedley College and the North Centers. Two points from the discussion were to investigate waste management technology with an emphasis on studying alternative ways to use waste to create energy, and to have students involved in finding ways to save money in the budget through green technology.
