Approval of Minutes

The minutes of the Board meetings of December 9, 2008, were presented for approval. A motion was made by Ms. Smith and seconded by Ms. Barreras to approve the minutes of the December 9, 2008, meeting, as presented. The motion carried unanimously.

Chancellor's Report

Dr. Crow reported the following:

<u>Budget</u> – The State of California is still without a budget, but the lack of firm numbers, however, has not stopped the District from planning for reductions. In the last couple of weeks, the campuses have been re-evaluating budget priorities by conducting a thorough internal budget audit. The State's mid-year cuts never occurred, but the District is focusing on slowing down spending this year and planning for cuts in the 2009-10 budget.

Dr. Crow commended the faculty, staff and administration at the campuses for their willingness to look closely at expenditures and make difficult choices about where to cut spending, while protecting the services and programs that directly impact students. The campuses have been able to maintain a full schedule of course offerings this semester, and are committed to retaining permanent faculty and staff.

Enrollment Update – Dr. Crow said that it's no secret that when the economy goes down, community college enrollments go up, and at SCCCD that is also the case. District headcount is up over 14% (32,000 enrolled) from last spring semester, which means more students on all of the campuses and sites--a very rapid growth in a very short period of time. It is a testament to the faculty and staff at the campuses who are accommodating the students and helping to change lives. Dr. Crow added that he is very pleased that students have chosen to attend here.

Bus Tour — The Career and Technology Education bus tour will again be offered this year on Thursday, March 26. Last year two large District buses filled with business, education, and community leaders throughout the Valley participated. The five-hour tour takes participants through many of the signature career and technology education programs. The tour begins and ends at the Manchester Center. The Summit from two years ago provided important input from business and industry. From that input, the instructors have done a good job in changing the way they structure their classes to assure that students are prepared for the workforce. Dr. Crow extended an invitation for the tour, and he also provided the Board with a DVD/video on career and technology education shown at the recent workforce forum.

Campus Reports

Dr. Azari reported on the following from Fresno City College.

- Dr. Marilyn Behringer and Sean Henderson will co-chair the Fresno City College Centennial Celebration Committee for the 100th year anniversary in 2010. The committee will include community members.
- Art instructor Kathy Wosika's "Paper or Plastic" artwork will be on exhibit at Gallery 25 through February 1.
- The Rampage staff won several awards at the Northern California Conference of the Journalism Association of Community Colleges. They won awards in general excellence, print and online publication, as well as a meritorious award for in-depth reporting for the "green" issue published Spring 2008.
- Students are invited to watch Inauguration Day events at designated locations on campus.
- Enrollment at Fresno City College is up considerably and every effort is been made to accommodate students.

Dr. Hioco reported the following from Reedley College:

- Eric Nasalroad, Instructor and a Pullman scholar, was
 selected by the State Center Entrepreneurial team to make a
 presentation at the Community College Entrepreneurial
 Conference. The Pullman Foundation will use the State
 Center program as a model for implementation with selected
 groups around the country. Eric is in the process of
 developing an entrepreneurial center on the Reedley College
 campus with a goal of creating an active business incubator.
- Aero student Natasha Pelham is a Pratt and Whitney
 Maintenance Scholarship recipient. Natasha is one of six
 students in the nation to receive the scholarship.
- On January 7, the faculty and staff were welcomed back during the annual Open Day Conference, featuring speaker Fran Solomon of PLAYFAIR, Inc.

 RC football player Terrance Montgomery signed with the University of Oregon. Dontae Smith is on the 2008 All-American team and was chosen for the All-California team along with Terrance Montgomery, Roberto Davis and Eric Johnson. Head football coach Michael White was recognized at the American Community College Football Coaches Association's national convention as the first elected president of the recently combined organization.

Dr. Kershaw reported on the following from the North Centers.

- The Spring 2009 duty day was held at the Madera Center on January 8.
- MCCAP Spring 2009 orientations were held January 5 and 9 at the Madera Center. The program is currently recruiting for Fall 2009. On January 15 approximately 120 high school juniors will take a field trip tour of the Madera Center. On January 21 and 28, the Madera Center will hold an orientation for students and parents highlighted by the current MCCAP students sharing their experiences and answering questions. Computerized placement testing is also scheduled.
- The Madera County Office of Education will hold the MCOE Academic Decathlon at the Madera Center on January 30.

Academic Senate Report

Ms. Linda DeKruif, Fresno City College Academic Senate President, reported the following:

- The Fresno City College Hayward Award nominee is Teresa Tarazi, instructor in the Humanities Division. Her name will be forwarded to the state level.
- Two issues the Academic Senate is involved with are learning outcomes and assessment, and the budget. They are listening to presentations regarding both course and program learning outcomes, and are working not only on implementing it, but also how to assess them. Regarding the budget, Ms. DeKruif said all constituents are important and that lines of communication need to stay open so everyone stays involved.

Classified Senate Report

Ms. Mary Helen Garcia, Reedley College Classified Senate President, reported the following:

- The RC Classified Senate represents Reedley College and the North Centers (Madera and Willow International Centers)
- At the Classified Senate's upcoming meetings, they will be deciding on what types of scholarship fundraisers they will be sponsoring. Four recipients of the Fall 2008 semester have received their renewable awards for Spring 2009.
- The deadline for the Classified Professional of the Year nominations is January 31.
- The MEGA Conference is Tuesday, April 7 and this year's theme is "You Are the Star!"

PG&E Power Pathways

Michael Quinn, Interim Vice Chancellor of Workforce Development and Educational Services, introduced Mr. Andy Crider, Director of the Career and Technology Center, who gave a presentation on the Power Pathways Program. The program is a joint venture between PG&E, Fresno City College, Workforce Connection and State Center Community College District. The objective of the program is to provide qualified entry-level employees who could pass the PG&E entry test battery, communicate in a technical environment, have soft skills for the workplace, and are physically ready for the demands of the job. The first class started in May 2008 with 26 students. All 26 students passed the PG&E entry test; 18 of the students became employed by PG&E.

Responding to questions from Board members, Mr. Crider said there were 1100 applicants for the program. The WIB used an assessment tool, interviews and drug tests to screen applicants. The minimum age for admission was 18 years of age. The demographics of the class represented the community.

The next class begins in January 2009 and is strictly for recently discharged veterans.

Mr. Smith and the Board members thanked Mr. Crider for the presentation and applauded the success and contributions of the Power Pathways program.

Consideration to Accept 2007-08 Audit Report [09-01] Action Mr. Brinkley introduced Mr. Larry Corum, CPA and manager of Vavrinek, Trine, Day, & Co. LLP office in Fresno, who spoke to the Board regarding the audit report. The two findings related to the 50 percent law compliance and the concurrent enrollment of K-12 students in community college credit courses.

- On January 30, the ASB is hosting Super Bowl activities with a video game tournament and football toss competition.
- Black History Month activities will include the attendance of Tyrone Smith, former San Francisco 49er, who founded Team

First and Goal, a nonprofit organization that encourages youth to attend college. He will speak at Reedley College on February 18 and the North Centers on February 19.

Fresno City College Student Trustee Ms. Natalie Nelson reported the following:

- ASG will be participating in the "March in March," in Sacramento on March 16, organized by the Student Senate for California Community Colleges.
- ASB and College Activities have teamed up for Welcome Week to aid students in finding their way around campus and to their classrooms.
- Over 30 clubs will participate in the first club rush of the semester. The clubs cater to the diverse interests of students and provide educational learning opportunities outside the classroom environment.
- The Spring Volunteer Fair will be held on January 21. Students have a variety of organizations from which to make their volunteer choices, such as Habitat for Humanity and Big Brothers and Big Sisters.

Mr. Smith said there has been discussion about SCCCD having a more eco-friendly presentation to the community and other community colleges. He and Chancellor Crow have discussed the possibility of adding student participation through a contest for students to submit practical ideas on how we can save energy and money. Perhaps this could be talked about at one of the Board retreats.
