#### Background:

The Personnel Commission is composed of three individuals who must be registered voters, reside in the State Center Community College District, and be "known adherents to the principle of the Merit System." One member of the Commission shall be appointed by the Board of Trustees, a second member shall be appointed by the Board of Trustees upon the recommendation of the exclusive representative, which represents the largest number of the district's classified employees (CSEA), and a third member shall be appointed by the other two members of the Commission.

No member of the governing board of any community college district or county board of education shall be eligible for appointment, reappointment, or continuance as a member of the commission. During a commissioner's term of office, a member of the Personnel Commission shall not be an employee of the State Center Community College District.

"Known adherent to the principle of the Merit System," with respect to a new appointee, shall mean a person who by the nature of his/her prior public or private service has given evidence that he/she supports the concept of employment, continuance in employment, in-service promotional opportunities, and other related matters on the basis of merit and fitness.

The Board may interview prospective appointees. Interviews and deliberations on the appointment occur in open session.

The Board of Trustees shall publicly announce the name of the person it intends to appoint. At a Board meeting to be held after 30 and within 45 days of the date the Board publicly announced its candidate, the Board shall hold a public hearing to provide the public, employees, and employee organizations the opportunity to express their views on the qualifications of the person recommended by the Board of Trustees for appointment. At the January 8, 2013, regular board

meeting, The Board of Trustees may make its appointment or may make a substitute appointment or recommendation without further notification or public hearing.

## Recommendation:

The Board of Trustees has reviewed the candidates' resumes and after discussion and consideration, may announce its candidate and designate January 8, 2013, at 4:30 p.m., as the date and time for the public hearing prior to the Board of Trustees' appointment of the district's commissioner.
