Ms. Campbell stated Human Resources met with the Director and that Ms. Gomez is aware of the District's interpretation. Ms. Campbell met with Ms. Gomez and the recommended salary was agreed upon.

Ms. Freeman-Fobbs stated she is inclined to agree with the Director of the Personnel Commission. Ms. Freeman-Fobbs stated that if the District were to challenge this in the future the Personnel Commission staff would seek a legal opinion.
