Delegations, Petitions, and Communications

Mr. Bill Carr, CSEA President, congratulated the Board members that were re-elected and stated that he looks forward to working with the Board in the coming year.

Chancellor's Report

Mr. Brinkley gave an update on Dr. Crow's recovery from knee replacement surgery.

Mr. Brinkley also provided an update on the Governor's proposed budget, which includes 3% growth and a 3.9% COLA. At this time, there is no provision for equalization funds for low-funded districts. He will be attending a budget workshop in Sacramento on Thursday.

Campus Reports

Dr. Doffoney reported the following from Fresno City College:

- Adaptive P.E. instructor Chuck Keller is the recipient of the Professional Recognition Award from the California Association for Postsecondary Education and Disability.
- The men's basketball team is off to a 17-0 start and 2-0 in Central Valley Conference games. The home opener is against Modesto Junior College on January 12.
- The women's basketball team is off to a 2-0 CVC start and will visit defending CVC champ Merced College on January 12.
- Opening Day Ceremonies for African American History Month will be held on January 31 at 10 a.m. in the Theatre. The Dallas Black Dance Theatre will perform at 7 p.m. at the Tower Theatre on February 1.

From Reedley College, Dr. Hioco reported:

- Student Bao Vue was one of six delegates chosen to represent the Pacific and Southwest regions of the Central California Consortium at the U.S. Forest Services' centennial conference in Washington. D.C.
- English Instructor Carey Karle was a coordinator and wrote the introduction to the recently published <u>50 Ways</u> to <u>Develop Strategic Writers</u> textbook for grades 4 through 12.
- The college has introduced "RC @ Night," a new program in which a student can earn an associate degree in general studies by taking night classes at the college, Sanger High School, or the Dinuba Center.
- More than 100 first-time students and their parents attended the New Student Welcome on January 5.
- Opening Day activities for faculty and staff on January 6.
- Tiger Business Connections (Students in Free Enterprise and Virtual Enterprise) is coordinating an on-campus donation drive for the victims of the Tsunami disaster.

- Thanked Phil Gonzales for serving as the State President of the Association of Mexican American Educators (AMAE) during the past year.

Academic Senate Report

Mr. Ron Nishinaka, President of the Reedley College Academic Senate, reported on the following:

- Election of 2005 Academic Senate Officers. Mr. Nishinaka will continue as the President for another year.
- Bill Turini has been nominated for the Hayward Award for Excellence in Education.
- Program Review process and handbook revision.
- The Reedley College and Fresno City College Academic Senate representatives will meet later this month to collaborate on the final draft of the Academic Accommodations Review Procedure.
- At the North Centers, three full-time permanent track faculty positions have been approved for next year. They include replacements in Math and Counseling, and a new position in Chemistry. Faculty and staff continue to work aggressively on the accreditation process with their colleagues at Reedley College.
- In conclusion, Mr. Nishinaka congratulated the re-elected board members.

Measure E Update

Mr. Brinkley provided a PowerPoint presentation on the District's Measure E projects.

Regarding the proposed southeast site, Mr. Forhan asked if a donation was still a component of the purchase negotiations.

Mr. Thonesen stated that he would like the administration to look at all possible sites for the Residence Hall. He noted that some members of the committee thought the Residence Hall should be centered more on the campus.

Measure E Update (continued)

Ms. Shah questioned the location of the parking expansion in connection with the Old Administration Building renovation. She also asked what the renovations include for the Fresno City College gym and student services area.

Mr. Forhan asked if the hard costs remain high, is there a point where the District will have to prioritize the projects. Regarding the Old Administration Building, he noted that if the numbers are off there will be a dramatic impact on the \$25 million allocated in terms of the finished product. A lot of people will be disappointed if the funding is reduced from 20 percent to 40 percent.

Mr. Tom Riggs, attorney with Lozano Smith, discussed the rules and regulations of Proposition 209 as it relates to bidding on public works projects.

Ms. Barreras confirmed that contractors cannot be asked about the ethnic makeup of their staff.

Mr. Forhan verified that trying to reflect the community in the hiring of contractors is illegal, and questioned if the District has a choice of selectively advertising in publications.

Ms. Shah questioned if sports program expenses come out of the general budget.

Mr. Thonesen inquired about ways to lower the District's retirement and medical liability. If costs keep going up, the District's value will go down. To lower the liability, the District may have to take money from the general fund and place into this expenditure category.

Ms. Smith noted that last year she asked for more explanation to be included in the audit report and would like the costs for students to be shown. Mr. Cowles explained that the audit document is designed to be used by financial institutions. A supplemental report can be provided at an additional cost. Mr. Patterson added that detail information is provided in the budget document.
