Chancellor's Report

Dr. Crow reported the following:

Classified Professionals Leadership Graduation – On Friday, December 5, approximately 25 classified professionals graduated from Leadership State Center. The ceremony took place at Fresno's City Hall. Trustees Dorothy Smith, Ron Feaver, and Isabel Barreras represented the Board. This program, under the leadership of Janice Emerzian, is a one-of-a-kind staff development program that has garnered national attention for its innovative approach to developing "home-grown" leaders throughout SCCCD. Dr. Crow commended the graduates on their achievement.

<u>Hello's and Goodbye's</u> – On behalf of the SCCCD, Dr. Crow welcomed Richard Caglia as the new member of the Board of Trustees.

Chancellor's Report (continued)

Dr. Crow thanked Dr. Guy Lease for his leadership as Interim President of Fresno City College and wished him well in his next endeavor. His tenure with FCC will end December 31. Dr. Lease has provided leadership for FCC and has been a valuable member of Chancellor's Cabinet.

Dr. Crow extended best wishes on behalf of SCCCD to Mr. Ron Nishinaka who is entering retirement at the end of the fall semester. Ron has been with the District over 37 years and has served as Academic Senate President for nine years. Dr. Crow thanked Mr. Nishinaka for his service to Reedley College and the District.

Campus Reports

Dr. Lease reported the following from Fresno City College:

- Congratulations to the FCC volleyball team for their third place finish in the state championships. Second-year coach Tracy Ainger-Schulte was voted as CVC coach of the year. Blocker Taylor Lucero and setter Lauren Manzo were named to the all-tournament team.
- Congratulations to the FCC wrestling team for winning the Northern California title. Four wrestlers won individual titles, and Steven Urquizo was named outstanding wrestler.
- In soccer, both men's and women's teams were conference champions. Women's head coach Oliver Germond was named CVC coach of the year, and Alex Clifton was named CVC MVP.
- FCC chemistry instructor Robb Culp is back to work after recovering from a life saving operation to donate a kidney to an ailing man he met through his church in Easton.
- Holiday gift baskets and money donated by faculty and staff will benefit 325 FCC students. Dr. Lease thanked Jeanine Castle for her work on this project.
- Dr. Lease expressed his appreciation for his assignment as Interim President of Fresno City College and the opportunity to work for SCCCD. He added that Fresno City College is a great college with extraordinary people, and it has been a pleasure to work with everyone throughout the District. He gave his congratulations on the choice of Dr. Cynthia Azari as the incoming Fresno City College President.

Mr. Smith thanked Dr. Lease, stating the Board has received good reports about his performance as Interim President at FCC, and the praise he is receiving is well deserved.

She has served as the Alpha Gamma Sigma Advisor from 1974-85, and the Academic Senate Secretary 1994-97. She continues to serve on the college scholarship committee.
- ASCCC Exemplary Program Award The Forestry/Natural Resources program is the RC/NC nominee for this highly coveted State award. The program is the only Society of American foresters recognized technician program in California. Student job placement has been 100% for over 30 years. Mr. Nishinaka introduced the program instructors Rob Cannell, Kent Kinney and Jason Pinkerton.
- The Academic Senate congratulates Trustees Ron Feaver, Pat Patterson, and William Smith on their re-election to the governing board, and special congratulations to new Trustee Richard Caglia on his election.

Mr. Nishinaka is retiring after a 37-year teaching career at Reedley College. Since this is Mr. Nishinaka's last Board meeting presentation, he took a few moments to thank the Reedley College and North Centers faculty for the opportunity to serve as their Academic Senate President. He acknowledged the dedication of the current executive committee and past officers. He also thanked the senate presidents from Fresno City College, Rick Santos and past presidents for the collaboration and dialogue, which has been highly beneficial for faculty. He expressed his appreciation for the opportunity to have an enjoyable faculty position in career technical education, as well

as leadership service opportunities as L.A.N.D. department chair and farm laboratory coordinator. As a non-English speaking student who was born in a relocation camp in World War II, he was fortunate to be a product of the Reedley school system including Reedley Junior College. On behalf of the Academic Senate Executive Committee and colleagues at Reedley and the North Centers, he wished everyone a very Merry Christmas and Happy New Year.

Board President Willie Smith thanked Mr. Nishinaka for his loyal service to Reedley College and the State Center Community College District. He wished him the best in his retirement.

Classified Senate Report

Mr. Ernie Garcia, Reedley College Academic Senate President, reported the following:

- On behalf of the FCC Classified Senate, Mr. Garcia welcomed incoming trustee Richard Caglia.
- Fresno City College Classified Senate held their staff development day on November 11; they have received positive comments.
- Conducted two training sessions on travel and conference procedures and forms. A combination of classified and faculty attended. Kudos were given to acting treasurer Shanna Ahrens for planning and presenting the workshop. More training workshops are being planned.
- Planning to present a health fair in the spring semester.
- The next Classified Senate meeting is December 17.

One-Year Status Report, SCCCD 2008 Strategic Plan Cynthia Azari presented a one-year update on the SCCCD 2008 Strategic Plan approved by the Board last year. The Board were provided copies. There are five goals and each goal has a number of objectives. Dr. Azari provided a report on the extent the goals are being met. The goals are as follows: 1) Access and Awareness, 2) Excellence in Teaching and Learning, 3) Workforce Readiness and Communication, 4) System Effectiveness – Planning and Assessment, 5) Resource Development.

Ms. Barreras asked about the apprenticeship programs and what we are doing to increase these types of programs.

Mr. Patterson commented that he has heard about new technologies at the CCLC conference. In talking with deans and faculty, he found it refreshing to know that our instructors are keeping up with technology training in their own fields and excited about being on the forefront.

2008-2009 Budget Update Doug Brinkley presented an update on 2008-09 SCCCD Budget, as it pertains to the state budget crisis, and covered the following:

- Historical Perspective of 2007-08 Budget
- State Budget General Assumptions
- Status of 2008-09 Adopted District Budget
- Comparison of District Budget to State Adopted with and without Chancellor's Office Growth Analysis for the System
- Evaluation of Governor's Midyear Cuts
- SCCCD Plan to Address the Reality of Cuts

Mr. Caglia asked about lobbyists for the District.

Mr. Brinkley responded the District has two avenues of lobbying: The Community College League of California and the School Services of California. The District has a contract with School Services of California to lobby on the District's behalf. Deborah Harmon is the District's representative, who also works closely with the League's president, Scott Lay.

Ms. Smith added that local Board members participate on legislative committees through the state organization (CCCT) and an annual state legislative workshop in January.

Dr. Crow discussed the planning strategies being taken while waiting for budget decisions from the state legislature. At this point "what if" scenarios are being developed for each campus and district department. Two things the District is keeping at the forefront in dealing with the state budget crisis is commitment to student access and maintaining permanent employees—faculty, administration and classified professionals. He discussed the following planning points:

- Evaluate all replacement positions
- Develop base budgets with all permanent employees included
- Reevaluate extended contracts/overtime/extra hours
- Reevaluate the use of lottery funds
- Review revenue potential opportunities
- Continue to be politically active with lobbyist, legislators, and others who may influence budget decisions

Dr. Crow added that the Board will hear a recommendation at the March retreat for use of 2009-10 lottery funds. He stated the four-week summer session will be decided upon early in January 2009. We are taking the Board's lead in a conservative viewpoint, but also the Board's lead in wanting to promote access and opportunities for as many students as possible. At the January retreat, the Board will receive another update, and hopefully will have some preliminary direction from the legislature.

2008-2009 Budget Update (continued)

Ms. Smith asked about the use of District's reserves.

Dr. Crow responded that he is very hesitant about committing any significant portion of the reserves. In the past, the reserves have been used when the state budget was late and the District had to fund salaries and operations.

Mr. Patterson recalled his position was in opposition to using reserves for the Old Administration Building at the time it was approved by the Board. He thinks that the use of the reserves for the OAB could be delayed, and should be an option rather than dropping classes, faculty and opportunities for instruction.

Mr. Smith added that the OAB is the means for expanding our student body. At this point he is not willing to go back and rewrite the page. He asked Chancellor Crow to see if the issue could be added as an additional item for discussion at the retreat.

Mr. Thonesen stated his support for the Board's decision to fund the OAB from reserves because it demonstrates the commitment to the community and to the bond measure they approved to restore the building.

Ms. Barreras said that because of the budget situation, it is time to be creative, and is looking forward to the ideas that will be presented to the Board.

Reedley College Student Trustee Tiffany Lowe reported the following:

- ASB annual food drive is providing dinner certificates from the Mainstreet Café in Reedley for student families in need.
- Clubs are adopting families and providing gifts to the children of needy families to brighten their holiday. This project is done in conjunction with Jefferson Elementary School.
- Santa will be on campus on December 12.
- In honor of Kingsburg's annual Festival of Lights events, Santa Lucia day will be celebrated with an open house at the Student Activities Office on December 12.
- The Substance Abuse Awareness Committee will be distributing alcohol-free recipes for holiday drinks the week of December 8-12 to promote safety during the holidays.
- ASB will be hosting a coffee break event on December 17 to thank club advisors.

Fresno City College Student Trustee Natalie Nelson reported the following:

- At the monthly Club Rush, ASB collected over a hundred signed letters from students who are opposed to any budget cuts to California's education. Two ASG officers visited California assembly members and their representatives to deliver the letters and explain the students' position.
- On November 21 ASG sponsored the first Student Leadership Experience. The event was a smashing success with over 100 students and advisors attending. Leadership presentations were given by several ASG members.
- FCC held the annual World Aids Day event on December 1. The ASB had many informational organizations from Fresno County participate.
- The ASG donated \$3,000 for gift cards to help support and lift spirits of struggling FCC students during the holidays.
