Chancellor's Report

Dr. Redwine reported that as a part of the District's efforts to strengthen diversity, a presentation by Dr. Terry Roberts with the Museum of Tolerance, and one of the original "Little Rock Nine," has been scheduled for October 10. Presentations will be made at 12 noon at Reedley College and at 3:00 p.m. at Fresno City College.

Dr. Redwine also announced that the District will resume the search for the Fresno City College President; the ads will reappear in November, with interviews scheduled for February and March.

North Centers Report

Dr. Yeager reported the following from the North Centers:

- Enrollment figures are up: Clovis 19%, Madera 17%, and Oakhurst 14%.
- Nine new full-time faculty and one full-time counselor have been added, bringing the total to 48 full-time faculty, 171 adjunct faculty, and four full-time counselors.
- The final working drawings for Phase 1-B at Madera are near completion.
- The North Centers now have their own student government, as well as an Alpha Gamma Sigma Chapter.
- The new Teacher's Cohort Program is up and running this semester.
- Received a \$335,000 grant to develop the LVN Program.
- Initiated the Madera Center College Advantage Program this semester in partnership with Madera High School.
- Added a College Center Assistant position to direct the student activities program.

Dr. Mark Harmon, psychology instructor and advisor to the Student Government introduced Brian Gamble, Student Government Vice President, who gave an update on their activities.

North Centers Report (continued) Mr. Robert Haller, Accounting/Business/IS instructor and advisor to the Alpha Gamma Sigma Chapter, introduced President Gloria Furnish. Ms. Furnish provided an update on Alpha Gamma Sigma activities.

Mr. Phil Gonzales, Counselor, introduced Maria Mendez, a Madera Center College Advantage Program student. Ms. Mendez commented on the opportunity to get ahead by achieving high school and college credits at the same time.

Dr. Yeager introduced Allisha Ross, the new College Center Assistant. Ms. Ross gave an overview of the Student Activities Program for the year.

Dr. Yeager also introduced Brent Nabors, Information Systems Instructor, who gave an update on the Teacher's Cohort Program.

Campus Report, Fresno City College Construction instructor Eric Nitzsche recently found himself in the spotlight. Eric was profiled by the Building Industry Association of the San Joaquin Valley in a column titled "BIA Salutes..." The article discussed how Eric and his students build a house in one school year. This is Eric's sixth year at FCC.

Six FCC staff members will participate in the "Walk for the Gold" on October 6 at CSUF to benefit Special Olympics of Northern California. District Associate Dean of Financial Aid Joaquin Jimenez is chairing FCC's involvement.

Painting Landscapes, a new play by theatre arts instructor Chuck Erven, opens in the FCC Theatre October 11. The play is Chuck's fourth play to be produced. Tim Quinn is directing the production which runs through October 20.

Walkers and sponsors are now being recruited for this year's Juvenile Diabetes Foundation Walk to Cure Diabetes on October 20. The walk will be held at FCC for the second year in a row and will start on the west lawn. FCC's goal is to raise \$40,000. A number of fund raising events are now being held on the campus.

Art instructor Anne Scheid was one of four artists featured in El Camino Community College's "Shades of Gray" exhibit. The exhibit, which closed in September, presented innovative and divergent approaches to drawing.

The Rams will be on the road this weekend to defend their undefeated record this season. The 4-0 Rams so far this year have

The Fiesta parade begins at 10:00 a.m. on Saturday. Reedley College students and staff members are involved in the festivities in a variety of ways, such as designing parade floats, exhibiting their artwork, and supporting local service clubs.

Author Molly Giles will be the featured speaker at the Fall Speakers Series event on Thursday, October 25 at 7:00 p.m. in the Forum Hall. Ms. Giles is a professor of creative writing at the University of Arkansas and the author of a novel and two short story collections.

Academic Senate Report Ms. Cynthia Elliott, instructor and Academic Senate State Representative from the North Centers, gave a status report on several proposed Board policies. She also stated that the ratification of a Faculty Association is in progress. This will serve as an Academic Senate-like structure for improved communication between faculty, classified, and administrators at the North Centers. Her journalism class will launch a "web newspaper" on October 15 and will include a report from this meeting. The International Club has reconvened to sponsor and publicize a French and Spanish music Christmas concert. This activity is entirely student-driven. The ASG Honor Society will sponsor a student vs. teacher softball game on October 7 at Clovis Rotary Park. The ASG North Centers will attend its first regional meeting on October 20.

Classified Senate Report Ms. Nancy Prosperi, North Centers Classified Senate Representative, gave the following update on the Senate's multilevel projects and activities dedicated to the realization of professional growth for all District classified employees.

On a District level, the committee and its chair, Dr. Janice Emerzian, are continuing to coordinate the second annual Staff Development Day for all State Center classified professionals. This year's event, scheduled to be held April 9, 2002, at Fresno's Pardini's and Piccadilly Inn, will be chaired by Irene Archuleta, Fresno City College, Marilyn Haines, Training Institute, and Carl Simms, District Operations.

On an individual level, a series of on-site technology training classes continues with "Spreadsheets-MS Excel." Committee members serve as facilitators for these classes. The next inservice, in conjunction with the Training Institute, will be held on Thursday, October 11 at the following sites and times:

We are looking at the possibility of using our computer labs at the North Centers for the December and subsequent classes in the series.

At a level of meeting a specific need of many classified professionals is the concept of the "cohort," an educational "buddy system" encouraging and enabling many employees to meet a specific goal. Some of our members have taken or will be

Classified Senate Report (continued) taking advantage of this concept to achieve their Bachelor's and/or Master's degrees. Fresno City College has now afforded us the opportunity to achieve an Associate of Arts Degree in Liberal Arts through the Weekend College. At our last committee meeting on September 27, 2001, Dr. John Spolsdoff, the new director of the Weekend College, spoke to us about the possibility of developing a cohort of SCCCD classified professionals. The best scenario would include a start date of Spring 2003, which would allow for an adequate time for testing and counseling. Units already accumulated will be evaluated and worked into the program. The 24-month program is arranged as a transfer program to the California State University and the University of California systems and meets on Friday evenings, Saturdays, and Sunday afternoons.

Finally, managers within our group are continuing to enjoy their involvement with Leadership State Center. In conjunction with our discussions resulting from our readings in <u>Stewardship</u> by Peter Block, new insights and ideas gained at these leadership meetings are shared at our monthly gathering of the Staff Development Committee. We are finding that these discussions are profoundly dynamic and are enhancing not only our professional lives but our personal lives as well.

The SCCCD Classified Professionals Development Committee has proven to be, and continues to be, a very positive force throughout the District in its support of the professional growth of classified employees. It has been a privilege to bring this report to you today.

Districtwide Marketing and Branding Report

Dr. Redwine stated that this report is a sample of a Decision Package that came out of Dr. Patterson's creativity and will give the Board an insight into the Decision Package funding.

Dr. Patterson introduced Aaron Scoby and Darrell Jennings with Channel 21, and gave an overview of the partnership with the station. She noted that Channel 21 is the number one rated Spanish speaking station, as well as the number one station in the Valley. The partnership will allow the District to reach Hispanic students and parents to provide information about the importance of attending college. She also provided a sample vignette of an ad to be run in connection with the program.

Mr. Patterson questioned if the District had translators available to respond to calls as a result of the ads. Dr. Patterson advised that she would ensure translators would be available.

Mr. Rowe stated that for the past several months the administration has been re-evaluating the organization of the campus Public Information Offices. The current organization structure at Fresno City College does not include a management position to oversee the Department's operations or employees. (Since Reedley College is a single-position office, this is not an issue.) Based upon the needs at FCC and the District, the administration is recommending the addition of a new position at Fresno City College titled Director of Marketing and Communications.

This is a management position and will have the responsibility of implementing District policies, regulations, budget decisions, and the supervision of personnel. The position will be under the supervision of the President but will work closely with the Executive Director of Public and Legislative Relations, as will the Reedley College Public Information Officer. Please refer to the proposed job description for a complete listing of the duties this position will be performing.

Consideration to Approve 2001-02 Decision Package Revisions [01-225] Mr. Sharpe stated that in May the Board of Trustees approved the basic Decision Package Program, which included an allocation of approximately \$2.4 million to the campuses and districtwide operations. Because of the changes in the State budget and other priority changes within the colleges, it was explained to the Board in September at the adoption of the districtwide budget there may be revisions regarding the priorities approved in May. The revised recommendations involve Fresno City College and the North Centers. Reedley College's recommendations have not changed.

Action

A motion was made by Mr. Forhan and seconded by Ms. Smith that the Board of Trustees authorize amending the 2001-02 Decision Package Program, as outlined in the revised Decision Packages. The motion carried unanimously.

Consideration of Bids, SCCCD LAN/WAN Renovations, Phase 2, Districtwide [01-226] Mr. Sharpe explained that this item has been amended as the recommendation was not completed at the time of mailing last Wednesday. This was due to the fact that staff needed additional time to analyze the two bids received. Based upon that analysis, the administration is recommending an award of Phase 2, which provides the circuitry and makes the WAN portion operational and sets everything in place for the final connectivity, which would be Phase 3.

Action

A motion was made by Mr. Patterson and seconded by Mr. Smith that the Board of Trustees award Bid #0102-06 in the amount of \$377,197.03 to Pacific Bell/SBC Communications, Inc., the lowest responsible bidder for the SCCCD LAN/WAN Renovations, Phases 2, Districtwide, and authorize the Chancellor or Executive Vice Chancellor to sign an agreement on behalf of the District. The motion carried unanimously.

Consideration of Bids, Lease of District-Owned Property, Reedley College Farm [01-227] Mr. Sharpe reported that in September the Board authorized going to bid for leases that were expiring for the Reedley Farm Program. The District has found that contracting out for the farm program has been very successful, both monetarily and for student programs. It is recommended that Parcels A-E be awarded to Surabian Packing Company. They were the only bidder on these parcels and are the current operator of the parcels. Surabian is also proposing the same percentage as received in the past several years. One bid for parcel F was received after the deadline and was, therefore, returned. The District will re-bid Parcel F for consideration in November.

- a) award a Lease Contract to Surabian Packing Company, Inc., for development and maintenance of Parcels A, B, C, D, and E on the Reedley College Farm;

The motion carried unanimously.

Consideration to Approve 2001-02 Partnership for Excellence Proposed Projects [01-228]

Dr. Bruegman stated that the District is in the second year of using the Partnership for Excellence (PFE) logic model developed by Cyndie Sine and Laura Wasserman. This model is used to select and monitor all the PFE projects funded. Persons wanting to apply for a PFE project respond to a campus request for projects. They must list quantifiable outcomes, how they relate to one or more of the five PFE goals that have been established by the State chancellor's Office, and specifically, how they intend to measure the outcomes. Our District has also asked that they include how each project will address campus goals and the District's Master Plan goals. After the projects have been prioritized and approved at the campus level, they are then transferred to the grid summary. Unfortunately, due to losing both Cyndie Sine and Laura Wasserman, we have not completed the outcomes grid for 2000-2001. The information, however, will be presented at the November Board meting.

Mr. Smith asked if the outcomes will portray how many students that graduated from the District moved on to other higher learning institutions. Dr. Bruegman explained that the PFE goals that address transfer will be included in the information.

Consideration to Approve 2001-02 Partnership for Excellence Proposed Projects [01-228] (continued)

Mr. Smith questioned if the information will include transfer to non-credit institutions. Dr. Bruegman stated that the State Chancellor's Office transfer goal is transfer to CSU and UC. We know that numerous students in the Valley are electing to go to National, Phoenix, or Fresno Pacific to obtain their baccalaureate degrees. The researchers are gathering this information and it will be shared with the Board once completed.

Mr. Manfredi expressed his appreciation for such a comprehensive report. On the North Centers report, Page 3. Project 11, and Page 4, Project 16, regarding the increase in fulltime faculty and reducing the number of part-time faculty, as we move toward college status, is there a statewide standard that requires a certain number of full-time faculty? Dr. Redwine stated the District will be working toward that, as it is our obligation.

Action

A motion was made by Mr. Manfredi and seconded by Mr. Corona that the Board of Trustees approve the 2001-2002 Partnership for Excellence recommendations as provided. The motion carried unanimously.

Members

Mr. Warren Bisel, Reedley College Student Trustee, reported the following:

- A "Relay for Life" will be held in the cafeteria tomorrow.
- The Oktoberfest activity was postponed because of the national tragedy in New York and Washington, D.C.
- The Reedley Fiesta will be held on October 12-13.
- Homecoming Week is October 22-26 and will include an introduction of the queen and king candidates and a barbecue, obstacle course, rock climbing, club carnival, and a reverse beauty contest. There will be a homecoming dance following the game on the 27th.
- A Best Halloween Costume Contest will be held on October 31 at 12 noon in the cafeteria.

Ms. Margaret Todd, Fresno City College Student Trustee, reported the following:

- Homecoming festivities will be held in October 27 at Ratcliffe Stadium.
- A Safe-n-Sane Halloween is scheduled for October 31 at Ratcliffe Stadium
- At the September Club Rush, over 350 postcards were signed and mailed to the Governor and other state representatives regarding the budget cuts.
- The Walk for Juvenile Diabetes will be on October 20 beginning at 7:00 a.m. on the west lawn. The school's goal is \$40,000.00.

- The California Community Colleges Student Affairs Association Conference will be on October 11-12.
- Thanked everyone for their support in connection with the train accident that took the life of a student. The entire funeral service was paid for by campus donations.

Mr. Manfredi stated that he enjoyed the presentations this evening from the students, staff and Channel 21. He also appreciated the Chancellor and Dr. Patterson's visit to Kerman to meet with the Mayor and him.

Mr. Corona thanked the Madera Center for their hospitality this evening. He also appreciated the Channel 21 presentation; having been raised in a Hispanic family, he understands how the opportunities for higher learning have to come to you. He enjoyed the recent Diversity Committee meeting and stated that the diversity in this country makes us strong.

Mr. Forhan stated he is pleased that Terry Roberts with the Museum of Tolerance will be making a presentation on October 10.

Ms. Smith reported that she looks forward to working on the Diversity Committee. She had the opportunity to attend the Central Valley Higher Education Consortium meeting on how the Central Valley can encourage students to go to college.

Ms. Smith also asked if the District is updating their security measures in light of the September 11 events. Mr. Sharpe stated that following the events of September 11 and following the tragedy on the Fresno City College campus, a districtwide meeting was convened to look at how we deal with crisis situations, and identified various procedures and issues that need to be addressed. Training opportunities are also being identified. The campus presidents provided information on their emergency/crisis procedures as well as efforts to assist students from Middle Eastern countries.

Future Agenda Items

Ms. Smith stated that she recently read an article on distance education and how it is a help to people who cannot travel to a campus. The data shows that people who usually take distance education courses also take classes on campus as well. She asked what the data shows for the District. Dr. Redwine advised that the fall schedule for distance learning, both for interactive television and the Web, will be mailed to the Board later this week. The information also includes a historic calculation of the number of courses offered for the past several semesters. We

have not collected any data on the nature of our students who are using distance learning, but we do not have any reason to believe that our data would be different from the national statistics.

Ms. Smith stated that the North Centers report mentioned a fee waiver for international students and asked if the District considered that in the aftermath of the September 11 tragedy. Mr. Sharpe explained that what was mentioned in the North Centers report was a new Board Policy regarding Student Payment Plans. This is part of the process of bringing recommended Board Policies to the Communications Council before they are presented to the Board. The North Centers requested a waiver of the \$25.00 administrative fee, which is allowed; however, it is not the administration's intent to recommend the \$25.00 fee.

Mr. Patterson requested that the Board adopt a resolution regarding the railroad and the safety of our students, speed of the trains, etc. Dr. Redwine stated that the administration will draft a resolution for the Board's review. Mr. Sharpe also gave a brief update on previous requests to the railroad regarding the speed of the trains, as well as possible alternatives to provide safety for the students and staff.

Closed Session

Mr. Thonesen stated that the Board, in closed session, will be discussing PUBLIC EMPLOYEE DISCIPLINE/ DISMISSAL/ RELEASE, Pursuant to Government Code Section 54957; and CONFERENCE WITH LABOR NEGOTIATOR [SCFT Part-Time Bargaining Unit], Randy Rowe, Pursuant to Government Code Section 54957.6.

Mr. Thonesen declared a recess at 5:40 p.m.

Open Session

The Board moved into open session at 7:00 p.m. Mr. Thonesen announced that the Board, in closed session, gave direction to its chief labor negotiator regarding part-time faculty negotiations.

Adjournment

The meeting was adjourned at 7:01 p.m. by the unanimous consent of the Board.
