Delegations, Petitions, and Communications

Mr. Dana Babcock of Central Valley Asphalt addressed the Board and thanked them for a recent parking lot reconstruction project at Reedley College. Mr. Babcock stated his purpose for addressing the Board is to request an opportunity to have the Board consider a change order to the above mentioned project. He has been advised by the Chancellor's Office to go through the process of forwarding his request to the Board for consideration. He is requesting the change order based on unforeseen circumstances stemming from increased oil costs. He provided a set of documents, including a chart.

Swearing In of New Student Trustee

Dr. Crow administered the Oath of Allegiance to Ms. Tiffany Lowe, Reedley College Student Trustee.

Chancellor's Report

Dr. Crow reported the following:

Fall Enrollment - The fall semester has officially started and enrollment is up nearly 7% districtwide. The increase is a direct result of the outstanding marketing and outreach efforts, including the highly successful "Extreme Registration" events held in August. Dr. Crow commended the staff for the hard work they put in over the summer in preparing for influx of incoming students. He thanked the faculty for accommodating the many students that showed up on the doorsteps at the start of the semester. He recognized the campuses for the creative efforts employed to help alleviate some of the parking stress. The shuttles and alternative parking lots have been very successful.

Chancellor's Report (continued)

<u>Budget Update</u> - The budget impasse continues setting new, yet unfortunate records for negotiations. This past Saturday, the Senate Republicans announced their outline for a budget compromise. The Republican plan does not include a sales tax increase and while it contains the same level of Prop 98 funding as Friday's Democratic plan, some \$2 billion of that is from secured lottery funds. Exact language of the proposal is still being drafted; a vote is expected any day.

Presidential Search Update - The national search for a new Fresno City College President is underway and the search committee, comprised of representatives from faculty, staff, administration, students, the community and the Board of Trustees will meet September 3 for the first time. The process will be conducted by search consultant Dr. Pamila Fisher. The plan is to have preliminary candidate interviews on October 21 and 22. Interviews for the finalist are scheduled for November 13 and, hopefully, have a recommendation for the Board of Trustees at the December 2008 Board meeting. Dr. Lease reported the following from Fresno City College:

- This Year's Muscular Dystrophy Association's Jerry Lewis Labor Day Telethon was broadcast to the Fresno area live from the FCC Theatre.
- Dr. Carolyn Drake has been selected to be one of the 2008 inductees to the Central San Joaquin Valley Nursing Hall of Fame. Ceremony is September 17 at CSUF Smittcamp House.
- The FCC Financial Aid Office has been designated a Green Lights office by the Institute for College Access and Success.
- AT&T has generously donated a gift of \$25,000 to purchase SmartPanel technology for use in classrooms in the OAB.
- Juan Chavez, Upward Bound and Hoover High School graduate, is a Gates Millennium Scholarship winner, and will be studying architecture at Cal Poly, San Luis Obispo

- English instructors Deborah Lapp, Emily Berg and Carey Karle are part of a focus group for the San Joaquin Valley Writing Project funded by the Center for Applied Linguistics

and the James Irvine Foundation. They are conducting "Writing Across the Curriculum" workshops at Selma High.

- The RC annual Transfer Day is September 11.
- RC will host the 2nd Annual Scholarship Awards and Reception on September 12.

Dr. Kershaw reported the following from the North Centers:

- The North Centers had a smooth transition into the Fall 2008 semester with enrollments significantly higher than last fall. Mr. Kershaw thanked the *Fresno Bee* and reporter Doug Hoagland for the recent feature article on the move towards full college status for the Willow International Center.
- The second year of the Central Valley Career Advancement Academy (CVCAA) grant has been awarded to Reedley College, Madera Center and Willow International Center
- Madera Center Dean of Students Monica Cuevas participated on the Educational Panel at the Latina Issues Roundtable.
- Madera Center political science instructor Reg Spittle will participate in the International Education Study Aboard Program during Summer 2009.

Academic Senate Report

Mr. Rick Santos, Fresno City College Academic Senate President, reported the following:

- The FCC Academic Senate is working on the Go Green campaign and is contacting the Associated Student Government to work in concert with them, and is looking at how they make this a stronger campaign.
- Faculty are moving in the direction of submitting all grades and paperwork online.
- The Academic Senate is seeking direction on the free speech issue in regard to rules and regulations for political speeches and activities on campus. They do not want to miss the educational opportunity in an election year such as this to have people on campus and to broaden students' understanding of the political system.
- The Senate is working towards strengthening communication with constituent groups and faculty across campus.
- Linda DeKruif is the FCC Academic Senate president-elect.

Classified Senate Report

Ms. Mary Helen Garcia, Reedley College and North Centers Classified Senate President, reported the following:

- The Classified Senate will hold their first meeting September 11.
- The Classified Senate is in the process of planning fundraising activities to supplement the scholarship fund. The Classified Senate awarded four scholarships this semester.

- Two were awarded to classified employees Michael Kaiser from Reedley College and Efrain Cuellar from WI. Two scholarships were awarded to dependents of Classified Employees Michelle Montelongo and Emily Berry. Two scholarship committee members are planning to attend the scholarship reception scheduled for September 12.
- The Classified Senate is holding a candied apple sale fundraiser in October.
- Flex Day activities are being planned for November 11.

Employee Diversity Report

Randy Rowe presented the Employee Diversity Report. His slide presentation covered the following:

- List of over 46 recruitment publications and sites used by the District;

- SCCCD Classified staff data comparing ethnicity and gender with Fresno/Madera Counties' workforce;
- SCCCD adjunct faculty, full-time faculty, and management compared to UC/CSU; and
- Student Diversity data showing percentages by ethnicity and gender.

Ms. Smith thanked Mr. Rowe for putting the diversity report together. Ms. Smith explained that her intent for requesting an agenda item was to gain an understanding of the hiring practices of the district and if what we are doing really reflects what our policies state. To gain that understanding Ms. Smith asked questions regarding the sensitivity during the paper screening done on the front end of the hiring process. She expressed knowing people of color who are qualified but do not make it to the interviewing process.

Mr. Rowe responded that every person that sits on a screening committee for an academic position, whether full-time faculty or administrator, has to go through an equal employment opportunity compliance training, which covers federal and state laws, and SCCCD administrative regulations. Committee members are trained to recognize responses to the criteria of the job announcement. One criteria is that SCCCD has a very diverse student population and the applicant must demonstrate to the screening committee a "sensitivity to and understanding of the diverse needs of the community college student."

Employee Diversity Report (continued)

Mr. Forhan suggested quantifying over a period of time those that are screened in and out. It is not a matter of questioning the process but rather to gain a quantitative perspective.

Ms. Barreras asked about how the screening committees are formed. Mr. Rowe responded by referencing Administrative Regulation 7120, academic senate and department procedures for committee assignments.

Mr. Rick Santos, president of the Fresno City College Academic Senate, described the process for assigning committee members. He added to the earlier discussion on screening that many applicants are screened out because the committee members are looking for those who have addressed each one of the criteria.

Ms. Smith inquired about the intern program, which she felt could be used to groom them to address questions in the interview process.

Mr. Rowe explained the programs and avenues in place within SCCCD are the Classified Professional Leadership, CCLASS for academic leadership, the intern program, as well as adjunct faculty.

Ms. Smith said that the background of an individual may not lend itself to being able to answer questions, giving language barriers as an example of one variable.

Ms. Smith commented on and asked about the male to female ratios in management. Mr. Rowe referenced trends from his presentation that show females in management in the District are at 43.6%, and added that SCCCD is moving toward a more balanced gender distribution in all areas.

Ms. Smith asked about including age as another part of diversity. Mr. Rowe agreed and mentioned several other factors in how diversity is defined. He said that not all the information is collected at the present time, but that perhaps more demographic information should be collected on SCCCD employees so that we can better address how diverse we are.

Ms. Barreras suggested contacting San Jose Evergreen Community College District regarding their hiring procedures.

Mr. Rowe said he would contact San Jose Evergreen and would also provide screening data to Dr. Crow as Mr. Forhan has suggested.

Mr. Patterson said that he appreciates the information and said the screening committees do a good job, and do it conscientiously. He appreciates the efforts of everyone involved.

Safety Update

Brian Speece, Vice Chancellor of District Operations, provided an update on the SCCCD Safety Program. The slide overview included the mission statement, safety programs, emergency response plan, emergency procedures, and emergency alerts. A quick reference emergency procedure guide has now been posted in offices and classrooms districtwide. Copies were provided for the Board.

Ms. Smith asked if SCCCD has a cell phone policy, and if every manager has first aid training.

Mr. Exum stated that the program was developed in cooperation with Library Services Dean Tucker and Ray Sanchez through Student Support Services. It incorporates college-level tutors at the high school who work directly with their students and create a bridge between the high school students and the tutorial center so that the students will be more comfortable coming to the tutorial center for service and help during their college classes. They are very excited about the agreement and the working relationship with the departments within Fresno City College.

Announcement of Proposed Board of Trustee Appointment to Personnel Commission [08-65] Action Mr. Rowe introduced this item and explained the two-step process according to the Personnel Commission rules that the Board will use to make their appointment or reappointment to the Personnel Commission. He explained that the Board is to make their intended appointment and also schedule a public hearing within 30-45 days, and at the conclusion of that public hearing the Board may appoint the person they announced, or appoint anybody they so choose without any further action. He recommended that the next regular Board meeting falls within the timeframe. Mr. Ron Manfredi had said that he would serve at the pleasure of Board, and the recommendation is being made that the Board announce that Mr. Ron Manfredi be the intended appointee, and hold a public hearing at the regular Board meeting on October 7. When the public meeting is over, the the Board is free to make the appointment of either Mr. Manfredi or anyone that the Board so chooses without any further action.

This has been going on for a number of years, and it makes it very difficult to manage a large institution such as SCCCD.
