Joint District and Campus Presidents' Reports Fresno City College President Tony Cantu reported on topics of interest from the District, Fresno City College, Reedley College, the Oakhurst and Madera Centers, and the Clovis Community College Center.

Academic Senate Report Fresno City College Academic Senate President Mary Ann Valentino reported on several Academic Senate activities taking place at Fresno City College.

Classified Senate Report Fresno City College Classified Senate President Susi Nitzel reported on several classified employee activities at Fresno City College, Reedley College, Clovis Community College Center, and Madera and Oakhurst Centers.

Transportation Services Update

Christine Miktarian provided an update on the transportation services provided by the District. The District will be recommending contract with rental companies for the services needed. The will be no impact on employees if the District decides to rent vehicles for

transportation services. The next step is to send out a RFP for the charter bus services. The District will come back to the Board with a recommendation for the authorization to award the charter bus services, authorization to utilize the State of California rental services contract with Enterprise, and authorization to sell the existing vans and buses. Trustee Arias requested information regarding the possibility of grant funding through the San Joaquin Air Pollution Control District, a report on the cost savings for operations and a complete inventory and age of the current fleet of Districts vehicles. This item will return to the February board meeting.

Direct Student Loans Update Kira Tippins, Director of Financial Aid, FCC, and Chris Cortes, Director of Financial Aid, RC, provided an update on direct student loans at Fresno City College and Reedley College. Ms. Tippins stated FCC will submit a revised default prevention plan to the Department of Education at the end of the month. It is important to avoid a default rate of over 30 percent in the third year. A default prevention task force in in place and the taskforce has been meeting monthly. FCC is on track, and hoping to come in under 30 percent in the third year. The consequence for having a more than 30 percent default rate is a possible loss of financial aid for the students. Chris Cortes reported on the RC default rates. RC also established a taskforce and developed a default prevention plan.

First Reading of Clovis Community College Center Self Evaluation Report for Initial Accreditation [14-93] No Action Deborah Ikeda introduced the Clovis Community College Center cochairs who worked on the report, including Kelly Fowler, Christopher Glaves, Leslie Rata and Jennifer Simonson. Deborah Ikeda reviewed the timeline for the accreditation process. Ms. Ikeda stated that although the presented report is a draft, there will not be any substantive changes to the report, only editorial. Staff will continue update and adding evidence to the report.

Trustee Arias had concerns about transportation, with respect specialty population (foster care, DSP&S, and welfare students, among others). Deborah Ikeda stated there is access to public transportation at the Herndon campus. The District provides van service between the Herndon campus and CCCC every 20 minutes.

Eric Payne stated there needs to be better clarification regarding the transition of Chancellors with regards to the DBRAAC and the changes to the model.

Second Reading and Approval of Proposed District Parking Fees and Fines [14-94] Action Christine Miktarian presented the updated proposal for the District's parking fees and fines. An adjustment to the proposal was made to keep the parking fees the same for part time students and faculty.

She stated there were no changes from the first reading. Trustee Payne stated there were a number of concerns that were brought up at the last Board meeting, that were not addressed.

Trustee Payne stated the District needs to hold individuals to a higher level of standards. The Districts Student Scorecard in comparison to others in the State, many of the sub-groups populations are represented at 40 percent, which is well below an "F" in terms of the students the District serves. If the District is a minority majority serving institution, the standards should be higher and have a higher benchmark. Since there have been no changes to the completion data in terms of the percentages, he cannot support the plan.

Second Reading and Consideration to Adopt the Fresno City College Student Equity Plan [14-99] Action Tony Cantu presented the FCC Student Equity Plan and addressed some of the issues raised at the last Board meeting.

A motion was made by Trustee Arias and seconded by Trustee Caglia that the Board of Trustees approve the Fresno City College Student Equity Plan. The motion passed without dissent.

Trustee Arias stated he is disappointed that he wasn't given enough time to review the document. He would like to receive the information sooner. He intends to fully read all documents presented to the board for consideration. Secondly, he is concerned that there wasn't more consideration to adding current District resources to add courses in order to serve more students.

Trustee Payne stated other institutions have matched the funds

provided by the state to support both faculty and staff to go along with the student success initiative work.
