RE:	2025 Annual Open Enrollment Period for District Health Insurance Benefits for Full-Time Employees Start Monday, August 4, 2025!				

The **2025 Annual Open Enrollment period** is just around the corner! From **August 4 through August 29, 2025**, all **benefit-eligible employees** are required to log in to their **BenefitBridge** account to review, update, or confirm their benefit elections for the upcoming plan year – October 1, 2025 through September 30, 2026.

Even if you're not planning to make changes, participation is **mandatory**.

You must actively confirm your elections in BenefitBridge to ensure continued coverage. If no action is taken, you and any eligible enrolled dependents will **automatically be enrolled** in the **Kaiser Permanente High-Deductible Health Plan**—the lowest-cost option—effective **October 1**, **2025**.

No exceptions will be made.

- Log into BenefitBridge and review your current benefits.

- Confirm, update or change your benefit elections and dependent coverage in BenefitBridge.

- If you plan to add an eligible dependent to your health plans, please gather the required dependent eligibility documents (listed in the 2025–2026 Employee Health Benefits Guide) and upload them to BenefitBridge before submitting your benefit enrollment.
- Understand your monthly payroll deductions.
- Attend an open enrollment meeting.
- Apply for Voluntary Long-Term Disability Insurance.
- Enroll or re-enroll in a Flexible Spending Account (FSA) with American Fidelity.
- Choose to pre-tax your medical payroll deductions (IRC Section 125).
- Enroll in voluntary products with Trustmark, AFLAC, or American Fidelity.

Health Plan Options and Payroll Deductions Effective October 1, 2025

All health plan benefits will remain the same for the 2025–2026 plan year. Below are the updated monthly employee payroll deductions. These new deduction amounts will first appear on your **September 30, 2025** paycheck, which covers your benefits for the month of **October**.

Voluntary Benefits

Voluntary Long-Term Disability (LTD) Insurance

Available to employees hired on/after September 1, 2013, who did not enroll during their initial enrollment period. Steps to Enroll by **4:30 PM, August 29, 2025**:

- 1. Make the voluntary long-term disability election in BenefitBridge.
- 2. Print and complete the Evidence of Insurability (EOI) form (available when you elect the benefit in BenefitBridge).
- 3. Submit the form to ReliaStar/VOYA (fax or mail) by August 29, 2025.
 - a. Keep a copy for your records.

^{*}Employees may elect pre-tax deductions under IRC Section 125.

- b. You'll be notified of approval or denial by ReliaStar/VOYA, please note this may take up to three months.
- c. If approved, deductions begin on the 1st of the month following approval.

Trustmark Universal Life Insurance with Long Term Care Rider

We're pleased to continue offering the Trustmark Universal Life Events and Universal Life programs as part of our voluntary benefits. Both are unique life insurance options that provide not only permanent life insurance coverage, but also peace of mind later in life with their Long-Term Care riders. If Long-Term Care assistance is needed, the plan pays out 4% of the policy's death benefit for 25 months to assist covering the cost of long-term care facilities. These plans also have a Death Benefit Restoration rider which restores the full death benefit, even if you utilize the Long-Term Care rider.

Flexible Spending Accounts (FSA)

Enrollment is required every year – FSAs do not automatically renew.

Meet with an American Fidelity representative to enroll in:

- Healthcare FSA: Pre-tax up to \$3,200 for eligible healthcare expenses.
- Dependent care FSA: Pre-tax up to \$5,000 for eligible childcare expenses.
