In addition, she reported on the District's efforts to update the public on Measure E progress and issues through electronic updates, *Fresno Bee* advertisements, press releases, and a dedicated page in the District's *Front & Center* newsletter.

Carrie Bowen thanked Dr. Patterson for the changes to the website in response to comments and suggestions made in last meeting.

Dr. Patterson also mentioned that television Channel 96 would be airing a 30-minute program each month that could include a segment on Measure E projects.
