- 2. Based upon Fresno campus, will there be ample parking?
 - i. Raleigh brought up the number of spaces for phase I and for phase II.
 - ii. There should be ample parking and access by city bus
 - iii. Carole mentioned the Bolt to college shuttle that is being used on other campuses
- 3. Cafeteria on site?
 - i. At first there will be pre-packaged food in the on-campus store.
 - ii. There will be a student union in phase II
 - iii. There might be opportunities for student-run lunch trucks to be on-site
